WHY WE'RE HERE


The U.S. South experiences a higher burden of HIV compared to other regions across the U.S., especially among communities of color.

In 2021, there were **492,922 people living with HIV in the South**.

That same year, the South made up over half (52%) of new HIV diagnoses.

Systemic issues like access to healthcare, barriers to care, racial and ethnic inequities, HIV criminalization, stigma, and more, contribute to HIV's negative impact on the South.


Rates of Persons Living with HIV per 100k, 2021

Carmarion Anderson-Harvey (she/her/hers)

Alabama State Director Human Rights Campaign

Carmarion D. Anderson-Harvey is a prominent transgender woman of color strongly committed to inclusivity and equality for all. She serves as the Alabama State Director with the Human Rights Campaign (HRC), making her the first transgender person of color to hold a leadership role in the organization's history.

Before joining HRC, Carmarion worked in public health and education, with a specific focus on HIV/AIDS prevention and reducing health disparities among marginalized communities. She is also the founder and former Executive Director of Black Transwomen, Inc. This is the first national non-profit organization with a 501(c)(3) programmatic focus that uplifts the voices, hearts, and souls of black trans women and is in alliance with the Black Trans Advocacy Coalition.

Carmarion has extensive experience in faith spaces as well. She serves as the National Administrator and South Regional Coordinator for TransSaints of The Fellowship of Affirming Ministries (TFAM). Additionally, she was an associate elder/minister at the Living Faith Covenant Church in Dallas, Texas, for 16 years before making her professional move to Alabama. Currently, Carmarion attends and serves at the First Congregational Christian Church, UCC, in Birmingham, Alabama, completing her Member-in-Discernment (MID) process for authorized ministry with the United Church of Christ (UCC).

Carmarion was raised in Dallas, Texas, with family roots from Natchez, Mississippi. She is the parent of one son and has three adorable grandchildren.



Michelle Au, MD, MPH (she/her/hers)

Representative, District 50 House of Representatives, Georgia

Michelle Au is a second-generation Chinese American from New York City. She was elected to serve as State Senator for District 48 in Georgia, becoming the only Senate member with an advanced degree in public health and the first Asian woman to serve in the Georgia Senate.

Rep. Dr. Au serves on the Budget and Fiscal Affairs Oversight, Public Health, and Special Rules House committees, and co-chairs the bi-partisan General Assembly Working Group on Addiction and Recovery. She helped form, and currently chairs, the bi-partisan General Assembly AAPI Caucus, the largest state AAPI caucus in the continental US. Dr. Au was honored to be a 2023 Nominee for the Gabrielle Giffords Rising Star Award from EMILYs List for her legislative efforts to protect reproductive healthcare. Rep. Dr. Au has been practicing anesthesiology for over ten years, and is a proud mother of two sons and a daughter.



Liliana Bakhtiari (she/they) City Councilmember, District 5

Atlanta, Georgia

Atlanta native Liliana Bakhtiari is the first nonbinary person elected in Atlanta, and the first queer Muslim to be elected in the state of Georgia. Councilmember Bakhtiari is the daughter of Iranian immigrants, and has been investing her time in issues she is passionate about since a young age. She has championed several issues around the world, including affordable education, affordable housing, women's and children's health, and environmental justice. In Atlanta, she has tackled initiatives such as voter engagement, services for unsheltered populations, and more. Bakhtiari currently serves as strategic director for the Blue Neighbors Project, curator of Black Futures Matter Collective, and the board of Georgia Equality.

Clover Barnes is a nurse executive with over twenty years of combined experience in healthcare and public health. A champion for health equity, diversity, and inclusion, Clover has a demonstrated track record of engaging staff and facilitating change while promoting an organizational culture that supports innovation, collaboration, and data driven decision-making. For the past seven years, Clover served as the Bureau Chief of the Care and Treatment Division of HAHSTA, where she provided excellent leadership and administrative oversight of the Ryan White Program and DC Health's Ending the HIV Epidemic Initiatives.

Prior to joining DC Health, Clover served in a myriad of healthcare/ nursing positions in her career including serving as Staff/Charge nurse, Clinic Coordinator, Nursing Manager, Ambulatory Manager, and Chief Operating Officer at a Federally Qualified Health Center.

Clover received her Bachelor of Science in Nursing degree from Milwaukee School of Engineering (MSOE) in Milwaukee, Wisconsin and a Master of Business Administration from University of Phoenix in Phoenix, Arizona. Clover has a passion for working with the underserved and invests her time and energy in improving the community in which she lives.

Under her brand "MarninaTheQueen," she leverages social media to address social injustices and raise awareness, with a substantial following and millions of video streams on platforms like TikTok, Instagram, and Facebook.

Her expertise in HIV stigma has earned her features in prominent media outlets such as Vice News, National Public Radio (NPR), and the YouTube Original Series: HIV Disclosure and Dating.

Ending the HIV Epidemic Initiative Coordination Lead U.S. Department of Health and Human Services Office of the Assistant Secretary for Health Office of Infectious Disease and HIV/AIDS Policy

Captain John Oguntomilade, BDS, MPH, PhD, is currently the Ending the HIV Epidemic (EHE) Initiative Coordination Lead in the U.S. Department of Health and Human Services (HHS), Office of the Assistant Secretary for Health (OASH), Office of Infectious Disease and HIV/AIDS Policy (OIDP).

CAPT Oguntomilade has served as the Acting EHE Lead for OIDP while also serving as the Prevention through Active Community Engagement (PACE) Director for Region IV (FL, GA, AL, MS, TN, KY, NC & SC). He is an active-duty U.S. Public Health Service (USPHS) Officer, a dentist, and a public health professional who provides leadership coordination and oversight to the national implementation of the EHE initiative. Before joining OASH in

August 2019 as the PACE Director for Region IV, CAPT Oguntomilade served with the Centers for Disease Control and Prevention (CDC) in Mozambique for four years, where he was the Associate Deputy for Program Management. At CDC, he provided oversight over all the CDC Mozambique's U.S. President's Emergency Plan for AIDS Relief (PEPFAR) partners. The CDC PEPFAR program provided HIV care and treatment services in six provinces with the highest HIV prevalence in Mozambique and received about \$200 million annually.

Prior to his tenure at CDC, CAPT Oguntomilade served at the Health Resources and Services Administration's (HRSA) Global HIV/AIDS program, managing its \$700+ million PEPFAR Catholic Relief Service program, which provided HIV care and treatment services in 10 countries across sub-Saharan Africa and the Caribbean. In the course of his duties, CAPT Oguntomilade traveled to 11 countries providing technical assistance, conducting program assessments, and supporting program transitions to in-country local partners.
